Applications for Career Exploration Grants are accepted throughout the year with no deadlines. Applications must be received at least four weeks prior to the start of your course or apprenticeship. Payments will not be made retroactively. Please contact your regional office to confirm application details.

All grants are subject to financial availability.

- A minimum of five years of professional performance, at least three of which were spent in Canada
- Paid member in good standing for three completed consecutive years.
- Must have danced a minimum of 30 months during the five year minimum performance period(CV template available upon request)
